IMPORTANT: If PG&E needs to turn off an electricity in an area for safety, **all customers** who receive power in that area will be affected.

If you require electricity for your medical needs, you may be eligible for PG&E’s Medical Baseline Program. **If you are a Medical Baseline customer**, your power can be shut off during a Public Safety Power Shutoff, but PG&E will provide advanced notice, giving you more time to prepare.
