The California Department of Health Care Services has reviewed and awarded nineteen (19) applications to narcotic treatment program (NTP) providers for opioid treatment, consistent with the federal grants issued by the Substance Abuse and Mental Health Services Administration (SAMHSA) – State Targeted Response (STR) Opioid Grant Program. Consistent with the 21<sup>st</sup> Century Cures Act-authorized funding issued by the Department of Health and Human Services (HHS) to address opioid abuse, California will be allocated \$90 million over the next two years. California’s successful grant application, entitled “Medication Assisted Treatment (MAT) Expansion” is focused on populations with limited MAT access including rural areas, American Indian and Native Alaskan tribal communities and statewide access to buprenorphine. The grant focuses on two projects: The California Hub and Spoke System (CA H&SS) and the Tribal MAT Project. The successful applicants and funding are listed below.

The 19 selected applications will serve as the “hubs” and cover 32 counties, 7 of which are counties in the top 10 counties with the highest opioid overdose rates. Over the course of the grant, these entities are projected to serve over 24,000 patients.

The remaining grant funds not allocated to the applicants above will be utilized to fund the Tribal MAT Project, as well as providing training conducted by the University of California, Los Angeles (UCLA) and the California Society of Addiction Medicine (CSAM). In addition, the project will conduct a statewide needs assessment and create a strategic plan.
