- Maintain a list of all non-assigned PHC patients to whom you rendered services as a result of the Valley Fire. The list must include the patients name, Partnership HealthPlan Member ID number, Date of Birth, and date of service.
- Submit the list of patients to PHC Provider Relations department via fax number (707) 420-7856 to ensure claims will be paid Fee-For Service.

If possible, when submitting claims, please note in the comments section on the claim "Lake County Fire", however this will not be required for payment.

## **MEMBER SERVICES**

### 24 hour Advice Nurse

If you need to speak to a nurse and cannot get in touch with your doctor, call our Advice Nurse 24 hours a day, 7 days a week at (866) 778-8873.

### **Primary Care Services**

Members affected by the fire can get medical services with any PHC primary care provider (PCP). Please call our Member Services Department at (800) 863-4155 for assistance locating a contracted provider near you.

### Medical Services Outside of Lake and Napa County

If you are temporarily or permanently living or staying in another county and need medical services, please contact our Member Services Department at (800) 863-4155. We can help you find a medical provider and pharmacy in your area.

### **Medication and/or Medical Supplies**

If your medication and/or medical supplies or equipment was lost or damaged due to the fire, call your pharmacy or medical supply provider and let them know you need an early refill or replacement due to the fire. You can also contact our Member Services Department at (800) 863-4155 if you need assistance.

### Pharmacies Closed Due to the Fire

If your pharmacy is closed due to the fire, please contact your doctor's or prescriber's office to have your prescriptions sent to a pharmacy that is open. You can use any pharmacy in Lake or Napa County to fill your prescription. If you are outside of Lake or Napa Counties you can go to most any pharmacy including pharmacies in grocery stores and pharmacy chains such as CVS, Wal-Mart, Rite Aid and Walgreens. You can also contact our Member Services Department at (**800**) **863-4155** for assistance locating a pharmacy near you.

#### **Mental Health Services**

Please contact Beacon Health Strategies if you're in need of mental health services. If you're already in the middle of care, please contact your current provider.

#### **Shelters**

All Evacuation Centers listed will accept small pets.

Big Valley Rancheria Gymnasium 1002 Osprey Court (off Soda Bay Road), Lakeport, CA. There is space for parking of self-contained RV's outside the shelter.

Clearlake Senior Center 3245 Bowers Avenue, Clearlake, CA

Cole Creek Equestrian Center 4965 Steelhead Drive, Kelseyville, CA With or without livestock. Space for self-contained RV's, trailers and tents.

Kelseyville High School 5480 Main Street, Kelseyville, CA

Kelseyville Presbyterian Church 5340 Church Street, Kelseyville, CA

Napa County Fairgrounds1435 N. Oak Street, Calistoga, CA.Petaluma Animal Services is available for evacuated pets and animals.

Redwood Empire Fairgrounds, Fine Arts Building 1055 North State Street, Ukiah, CA They have facilities for shelter of small animals and can also house some large animals. Directions: Coming from Lake County, take North State Street exit and head south. Go through two stop lights and take a left past KFC.

Seventh Day Adventist Church of Lakeport 1111 Park Way, Lakeport, CA Space for self-contained RV's. Lakeport Auto Movies 52 Soda Bay Rd, Lakeport, CA 95453 Space for self-contained RVs, trailers, and campers only. Please check in at movie theater office. Dump station available in Library Park near launch at 5th St in Lakeport, no potable water to fill tanks.
