

Enhanced Care Management (ECM) Duplication of Services

Criteria to Receive ECM		
1. ECM and the other program	Managed Care Plan (MCP) members can be enrolled in both ECM and the other program. ECM enhances and/or coordinates across the case/care management available in the other program. MCP must ensure non-duplication of services between ECM and the other program.	
2. Either ECM or the other program	MCP members can be enrolled in ECM or in the other program, not in both at the same time.	
3. Not eligible to enroll in ECM	Medi-Cal beneficiaries in the other program are excluded from ECM
