

Transportation Benefit and Mission

- Medi-Cal offers transportation to and from appointments for services covered by Medi-Cal.
 This includes transportation to medical, dental, mental health, or substance use disorder appointments, and to pick up prescriptions and medical supplies.
- There are two types of transportation for medically necessary appointments.
 - Non-emergency medical transportation (NEMT) is transportation by ambulance, wheelchair van, or litter van for those who cannot use public or private transportation.
 - Non-medical transportation (NMT) is transportation by private or public vehicle for people who do not have another way to get to their appointment.
- The plan's responsibility is to get members to their medically necessary Medi-Cal covered services using the least costly method of transportation that meets the member's needs.



Transportation Benefits



Non-Emergency Medical Transportation (NEMT)

Door-to-door assistance required

Medical management may be required during transport

Non-emergency ambulance, litter van/gurney, wheelchair van or medical air transport

Requires a Physican Certification Statement (PCS)



Non-Medical Transportation (NMT)

Member does not require assistance

Member must attest they have no other way to get to their Medi-Cal covered service

Least costliest mode of transport: Gas mileage reimbursement, taxi, public transportation or train



Travel Expenses

Meals, lodging, parking, tolls and other travel expenses for all qualifying members

One medically necessary attendant/parent of a child under the age of 21, can qualify for their own separate meal issuance

Allowances to cover meals, lodging and salaries for medically necessary attendant



Transportation Services at PHC

- NMT/NEMT transportation requests
 - Kinetik Trip Scheduler software is used to screen members, determine appropriate mode of transportation, make reservations and assign trips to providers
- Requests for travel expenses such as flights and lodging
- Member reimbursements for travel-related expenses and gas mileage reimbursement (GMR)
 - Driver/Payee credentials are managed in the Kinetik software
 - Must supply current driver's license, registration and insurance
 - Members cannot be reimbursed directly
- Public transportation passes

Transportation for IHS facilities

- Provisions under PPL 20-005
 - Allows for IHS providers to bill Partnership directly for NMT services
 - Providing Non Medical Transportation to American Indians
 - Do not have to coordinate travel through Partnership prior to travel
 - Can submit claims for NMT services under the group NPI via the claims process
 - Medi-Cal FFS rate with modifier codes (see Partnership IHS Billing update attachment)
 - No requirement to contract directly with Partnership to provide NMT for American Indians
 - Must be a Medi-Cal certified provider through DHCS to provide direct NMT transportation services

Indian Health Services Billing for Non-Medical Transportation Update

March 2023

Pursuant to the Department of Health Care Services (DHCS) Policy and Procedure Letter (PPL) 20-005, tribal health programs, also referred to as Indian Health Service (IHS) providers, can bill Partnership HealthPlan of California (PHC) for Non-Medical Transportation (NMT) for dates of service on or after October 10, 2018. Please see the updated enrollment and billing information below:

Medi-Cal Enrollment


• In accordance with PL 20-005, IHS must <u>enroll</u> in the Medi-Cal program as an NMT provider. IHS providers are encouraged to enroll within 30 days of this notification. Pursuant to federal law, PHC cannot pay claims to a provider who has the means to, but who is not enrolled in the Medi-Cal program.

Billing Information

Claims for NMT services must be billed under the **group NPI** and on a separate **CMS-1500** form with the appropriate codes, modifiers and location code 99. Note that the total number of miles should be billed on one line and a description of the trip including origination and destination address is required.

Indian Health Services Billing for Non-Medical Transportation Update

Transportation-Related Travel Services (Meals, Lodging & Tolls)

On May 18, 2022, DHCS released the updated APL 22-008 which expanded the transportation-related travel services benefit from only members under 21 to all members. Medi-Cal does not currently support codes related to meals and lodging and, as tribal health programs are not providing these services directly, there is no direct billing provision at this time.

A member or provider on behalf of a member may request meals and lodging services through Partnership by calling (888) 828-2303, at least five business days before service is required.

Through May 17, 2023, PHC will accept retrospective invoices from tribal health programs with dates of service on or after May 18, 2022, in cases where tribal health programs arranged and paid for meals and lodging necessary for members to receive Covered Services pursuant to PHC Policy MCCP2030. This exception is not intended to assign any delegated responsibility to tribal health programs or any other network providers for the administration of transportation-related travel services.

To receive retroactive reimbursement during this period, the following documentation must be provided:

- Receipt or invoice showing payment and date of service for the transportation-related service
- Member name, DOB and CIN
- Appointment date
- Type of service provided (lodging, meals, parking, tolls, etc.)
- Number of days/nights the service was provided and check-in/check-out dates if lodging was provided
- Documentation demonstrating that the transportation-related service was related to a Medi-Cal Covered Service

Transportation

 As of April 1, 2023, all transportation services are directly coordinated by Partnership's Transportation Services and can be requested by members and providers. Starting July 1, 2020, Partnership began administering substance use services to Medi-Cal beneficiaries in Humboldt, Lassen, Mendocino, Modoc, Shasta, Siskiyou, and Solano counties.



Provider Recruitment Program

October 2023 Update



Partnership HealthPlan of California's current Provider Recruitment Program (PRP) will conclude at the end of 2023. Partnership will announce a new set of workforce development initiatives for 2024, which will include an updated PRP. In advance of the 2024 changes that will be unveiled in the coming weeks and months, Partnership is making some changes available early due to immediate partner needs. This early update includes an enhanced signing bonus for physicians and nurse practitioners/physician assistants (NPs/PAs), and for the first time extends the sign-on bonus to obstetric providers (obstetricians, certified nurse midwives (CNMs), family medicine physicians and NPs/PAs, and women's health NPs) who focus on perinatal care, including labor and delivery.

Program Enhancements Available

Providers

- \$100,000 signing bonus for physician candidates
- \$50,000 signing bonus for NP/PA/CNM candidates
- Enhanced bonus disbursed over a five-year term

Behavioral Health Providers

- \$20,000 signing bonus for licensed behavioral health professionals: licensed clinical social workers, licensed marriage and family therapists, licensed professional clinical counselors, and licensed clinical psychologists
- Must have unique skill/specialty (i.e. bilingual, or from/connected with a culturally, ethnically, or racially underrepresented community, or possess specialty training)
- Enhanced bonus amounts disbursed over a two-year term

Key Criteria

- Candidates must not have accepted an offer to practice at a partner site under the previous PRP version.
- If the candidate is currently practicing, they must be from outside of Partnership's 14 counties.
- Providers in training or residency programs within Partnership's 14 counties qualify for support.
- Requests for program support must be provided to Partnership before formal offers are made to candidates.

Important Note

Organizations with an existing PRP grant agreement with Partnership must execute an amended agreement to participate with the updated incentives. Organizations not currently participating in the PRP must have executed a grant agreement to submit requests for grant funds.

Partnership Announces New Initiative to Increase Lead Testing in Primary Care

Partnership invites your organization to apply to participate in an exciting new initiative aimed at improving lead testing rates for age-appropriate pediatric patients in primary care clinics.

California mandates lead testing for children enrolled in publicly supported programs, such as Medi-Cal, but lead testing rates are below the national Medicaid Benchmark by 63.99% in all Partnership service areas. Since age-appropriate lead testing is crucial in identifying children with lead exposure – and success in testing is highly associated with in-clinic specimen collection – Partnership is awarding 10 primary care providers each new LeadCare II Point of Care (POC) testing devices across its network of providers.
