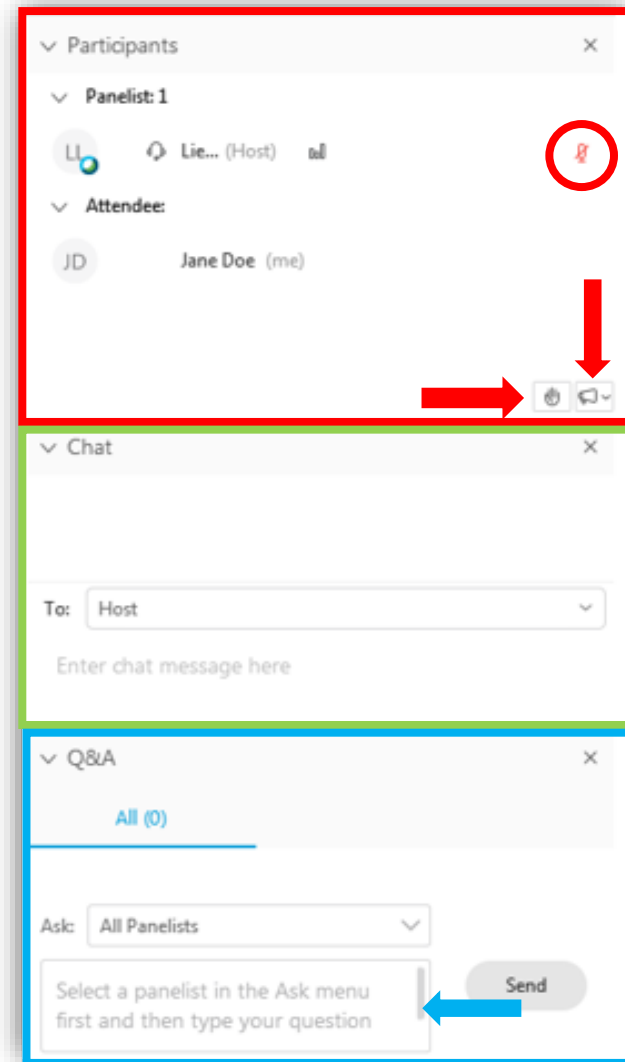
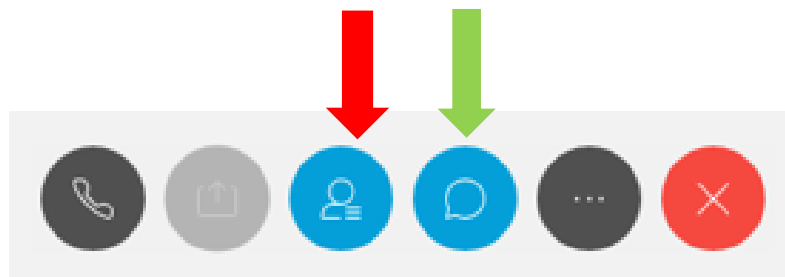

# PHC's Goal for BHI Grants

Partnership HealthPlan of California (PHC) has **committed to behavioral health integration and encourages as many grants as possible.**

- Persons with mental health and/or substance use issues are often those with unaddressed chronic physical health conditions (and vice versa).
- A significant proportion of PHC's members have behavioral health issues that require integrated treatment and follow-up .
- Integration and collaboration of services is key to our collective success in addressing the needs of our members.

PHC particularly encourages grants that involve collaboration among providers (i.e., primary care clinics and substance use providers, emergency rooms and Beacon providers, etc.).

- Statewide financial allocation
- Grant period: April 1, 2020 – December 31, 2022





# Who Can Apply for a Grant?

**Contracted providers with PHC or Beacon Health Options who serve Medi-Cal beneficiaries**

## **Types:**

- Federally Qualified Health Clinics (FQHCs), rural health clinics, Indian Health Service clinics
- Hospitals, medical groups, individual providers
- Mental health and substance use providers
- County mental health and substance use providers

# Components of Effective Integration Programs

- Patient Identification and Diagnosis
- Engagement in Integrated Care
- Evidenced-Based Treatment
- Systematic Follow-up, Treatment, Adjustment and Relapse Prevention
- Communication and Care Coordination
- Program Oversight and Quality Improvement
- Strategies and Practice Redesign Components



# Project Examples

## Behavioral Health Integration

- Increase screening, initiation of treatment and tracking of outcomes for Depression/Substance Disorder
- Building systems to track follow up for managing mood disorder and substance use disorder (SUD)
- Behavioral Health Staff for screening and follow up therapy
- Training clinical staff in Screening Brief Intervention Referral to Therapy (SBIRT)

## Maternal Mental Health Substance Use

- Increasing Behavioral Health staff in a CPSP/Prenatal program to screen all pregnant women for depression, RISK for depression and substance use
- Coordinating care for referral for substance use treatment, increasing X-Waivered prescribers or increasing referral to treatment with Opiate Use Disorder

## Medication Management in Co-Occurring Diagnosis

- Develop systems that identifies these individuals and coordinating services to ensure access to care and follow up labs and consults

# More Project Examples

## Diabetes Screening and Treatment in SMI

- Coordinating medical primary care services with County and primary care based psychiatric services
- Develop systems for shared care coordination and communication

## Follow After Hospitalization for Mental Illness

- Coordinating medical and mental health care across County, hospital and primary care services
- Develop systems for shared care coordination and communication

## Follow Up After Emergency Department Visits

- Coordinating medical, mental health, substance abuse services across County, Substance Use programs, hospital and primary care services
- Develop systems for shared care coordination and communication
