eREPORTS, PQD & Preventive Care Dashboard Data Refresh Schedule:

SYSTEM	FREQUENCY	DAYS	NOTES
eReports	Twice a week	Tuesdays & Thursdays	Update occurs during business hours. The QIP team recommends uploading before 5pm or use Monday and Wednesday as upload days.
PQD	Monthly	10th of the month	Prior month data displayed.
Preventive Care Dashboard	Daily	Monday - Friday	Supplemental reports. These reports are to be used in conjunction with eReports CIS10, IMA, W15 & WCV measure reports. They do not contain supplemental data such as upload and they do not apply the 14-day for CIS10 & W15.
