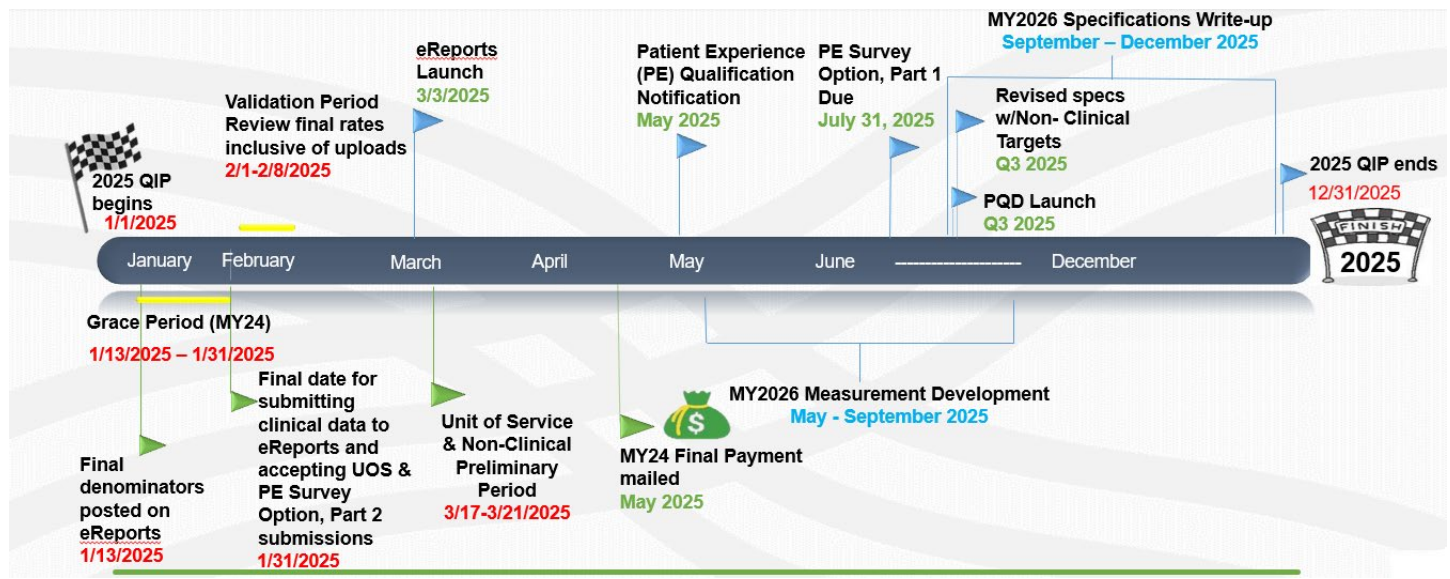

ePrompts is a tool within Provider Online Services that allows provider office staff to easily access Partnership members' clinical preventive screenings for which the member is due at the same time they are checking the members' eligibility.

Imagine a member calling to make an appointment to discuss an ongoing health concern with their primary care provider and, through ePrompts, front office staff can view the member's current preventive screenings and well visits, such as:

- **Breast Cancer Screening**
- **Cervical Cancer Screening**
- **Child and Adolescent Well-Care Visits**
- **Colorectal Cancer Screening**
- **Diabetes – HbA1c**
- **Diabetes – Retinal Eye Exam**
